Independent inspections of your products, at various stages of the product's life cycle, will ensure that the quality of your mass production will match that of samples tested and will help you to identify critical defects before products hit the market. Our qualified inspectors and inspection SOPs give us immense confidence in taking full responsibility for our conclusions regarding inspected product or activity/process.



INSPECTION & VERIFICATION SERVICES

➤ Status Check

Evaluation of order status against total order, actual raw material, in-process materials, production & packed quantities.

➤ Sample Evaluation

Verification of samples in conformance with technical specifications and approved samples, shades, material & quality parameters.



➤ Inline Inspection

An Initial Production Inspection will ensure your specifications are understood by the factory and to prevent any potential flaws in the production resources, materials, schedules, and management. An Initial Production Inspection (IPI) is an on-site Product Inspection performed once your production reaches up until 10% to 15% has been produced. A preliminary inspection of all materials to be used in your production, an IPI is the first step in ensuring the quality of your product will be consistent throughout production.



➤ During Production Inspection

A During Production Check (DUPRO) will identify any issues early in the manufacturing cycle, giving you the time needed to react and fix them. A During Production Inspection is an on-site Product Inspection performed when 30% to 50% of your production is produced. This inspection of randomly selected units from all completed batches of your production informs you whether or not your factory is continuing to follow your original specifications, and if your production is still on schedule.



➤ Final Random Inspection

Final Random Inspection is carried out once 100% of goods are produced and packed in export cartons. In FRI EQS-Inspector will cover (Quantity Verification, Product Style, Colour Conformity, Workmanship / Quality Check as per agreed AQL, For all FRI inspections, EQS-Inspection uses the standard internationally recognized ANSI/ASQC Z1.4 (ISO 2859-5) statistical sampling procedure. These comprehensive criteria cover functionality, performance, durability, overall appearance, and dimension. Inspection certificates are being issued upon the Client's special request.



➤ Supervision of Loading

Supervision of Loading/Container Load Check is the final step in the manufacturing process. Ensure the final details of your product are correct and the actual ordered quantity is securely loaded onto your container before signing off and settling the final payment. During a Container Loading, EQS-Inspector will select boxes at random to confirm each carton bears the quantity of product ordered, the quality matches the specifications, and/or approved sample provided by Client/Factory, and that all packaging material contains the correct barcodes, labelling, and packing materials. The entire container loading process is strictly supervised.



➤ Vendor Assessment

Technical evaluation of suppliers against their declared technical capacity and capabilities.

➤ Post Delivery Inspection

Quality assurance inspection check, specifically after delivery of goods on destinations. Quality assurance and quality control services help you ensure compliance with all contractual specifications, mandatory regulations & quality standards. we can help you assure quality throughout your entire supply chain.
